## **Final Comments & Questions**

The first thing to say is the thesis is too short and we will have to consult the departmental guidelines to see if it is possible for the thesis to pass in this condition.

The thesis seems more descriptive in nature rather than argumentative and research and secondary source material seems only to minimally inform the work. Considering the rather critical view of the way patriarchy uses marriage to disadvantage and control women in the introduction, I found the author's view of Jane Eyre's Mr. Rochester as somewhat generous and romantic. Considering he is an attempted bigamist and imprisons his first wife in chains, he seems to be the very definition of someone who uses the authority of marriage to his advantage while at the same time disregarding marriage's legal limitations that pertain to him. He seems like a patriarchal "slave" master mentioned in the introduction, rather than the "more sinned against that sinning" character described in the author's portrait of him. Do you think Jane would have been happy with him if he were a younger man, if he were not weakened by age, blindness, and injury?

I was more impressed with the author's examination of how women can embody the patriarchal position even as they prepare other young women to be subjugated. I wish the author had said more about this subject, as just this sort of collaboration is absolutely necessary for the marriage system of self-subjugation to continue. The conclusion I found insightful, as I think at long last, the author's thesis became clear. It is possible for independent and willful women to be happy in the institution of marriage, even if they cannot be ultimately happy or totally independent.

There are problems with the References page in terms of spacing and titles as well as a number of inverted quotations marks.
