Final Comments & Questions

The above assessed work deals with one of the morphological qualities of the English verb – the passive voice. It describes the passive from the structural-functionalistic point of view, which means it considers the passive from the point of view of its function as a means of expression. The author includes also the comparison with the Czech verbal category of voice from the point of view of the form and the use. The author proved her high ability to work with theoretical and technical literature in both, English and Czech. She provides complete characteristics of these grammatical means of expression in English as well as in Czech. The results of the comparison at the theoretical level are further used as the basis for the analysis of the passive constructions found in the original English text and its Czech equivalents.

The results of the analysis, provided verbally as well as graphically, show individual areas of usage of this grammatical means of expression in a literary text, ranging from the non-agentive use to the emphasis of the agent of the action. At the same time the Czech equivalents of the English passive structures are being considered, showing the main differences between the two languages. The relevant and clear conclusions drawn from the analysis are stated in the last part of the work. They make it possible to realize that the main differences in the area of usage the passive in the two languages lie first of all the fact that they are of different grammatical types.

The language of the work and the formal lay-out are outstanding. In my opinion, this work is an excellent piece of academic writing. The suggested evaluation: "výborně" (outstanding).
