Final Comments & Questions

The subject of effective objectives has undoubtedly its place in English language teaching and Mr. Votřel clearly demonstrated his interest and investigation into the topic.

The terminology of aim, goal and objective is first well explained, but further it is referred to the terms in a slightly confusing way (e.g. p.27). Also the references concerning appendices are not always clear, mostly the reference is just general without pointing to a corresponding appendix. On p.11 the reference to appendix 3 is wrong. It should probably be appendix 4. The author's voice is undoubtedly important, but not in the theoretical chapter (e.g. p. 17, 18 - I believe that, p. 23 - I would say). Nevertheless despite these shortcomings, the theory is logically structured.

The methods and results are sufficiently described and discussed. I suggest that the thesis is awarded a "very good" grade.
