## **Final Comments & Questions**

The above assessed work deals with a wonderful, purely grammatical topic – the syntactic description and analysis of the two non-finite verb forms, so typical of English – infinitive and gerund and their competition as the heads of dependent non-finite clauses with respect to their superordinate verb in the matrix clause.

In the theoretical part of her thesis, the author provides the description the non-finite verb forms themselves from the point of view of their form and from the syntactic point of view. Here she focuses on individual syntactic functions of the gerund and infinitives and delimits the semantic types of the superordinate verbs combining with them. This particular part of the theoretical background is really excellent. Nevertheless, the author does not pay enough attention to the description of morphological qualities of the infinitive and gerund within the frame of the category of non-finite verb forms and phrases. The combination of their morphological and syntactic qualities actually provides a perfect basis for the phenomenon, so typical of English – syntactic condensation. The author does mention it, but in my opinion not to a sufficient extent.

On the other hand, her analysis of the verbs combining with the infinitive and the gerund, is excellent. The whole issue is very confusing, but she was able to keep her way through the "jungle" of individual verbs and their various semantic features which influence the choice between the infinitive and gerund. She also did very well in summarizing the results of the analysis as well as in drawing conclusions based on the results.

The language of the work is at a very good level (regardless of a rather chaotic spelling of the verb to analyse/to analyze in the Abstract and the Introduction and the overuse of existential constructions with "there" through-out the thesis); the the formal lay-out is outstanding. In my opinion, this work is decent piece of academic writing. The suggested evaluation: "výborně" (outstanding).
